

Award for BVMI Chairman in Paris:

Florian Drücke receives German-French Prize of the Cultural and Creative Industries

Paris/Berlin, February 6, 2020 – Dr. Florian Drücke, Chairman & CEO of the German Music Industry Association (BVMI), was awarded the Franco-German Prize of the Cultural and Creative Industries ("Prix des Secteurs Culturels et Créatifs") tonight in Paris as "Personality of the Year". The prize is an initiative of the Franco-German Chamber of Commerce and Industry under the patronage of the German and French Ministers of Economic Affairs. The award was presented by Claudia Dörr-Voß, State Secretary at the Federal Ministry for Economic Affairs and Energy. In her laudation, Catherine Briat, Atos Germany, emphasised, among others, Florian Drücke's active support for the European Copyright Directive, saying the Directive was essential for maintaining and strengthening the European creative industries with Germany and France having worked on together to bring it to a successful conclusion. Briat went on that, furthermore, Florian Drücke had been committed to the Franco-German creative sector through his work as Chairman of the Executive Board of the German Music Industry Association and as Co-President of the Franco-German Cultural Council, with music in particular being one of the most important cultural industries for both countries in terms of markets, exports and creativity in Europe.

The prize underlines the economic relevance of the creative industries. In Germany alone, they employ around 1.195 million people in the core workforce, the total turnover is 168.3 billion euros and gross value added is at a record level of 100.5 billion euros (source: "Monitoring Report on the Cultural and Creative Industries 2019", German Federal Ministry for Economic Affairs and Energy/BMWi).

In this sense, the BVMI Board of Directors considers the award to Florian Drücke both as a personal distinction and as an appreciation of the music industry and the neighbouring sectors:

Florian Drücke studied law in Berlin and Toulon and finished his studies in France with the Maîtrise degree. In 2006, he became Legal Counsel at Bundesverband Musikindustrie e.V. (BVMI – IFPI Germany) and in 2008, he took over the legal department and the political lobbying as Head of Legal & Political Affairs. Since November 2010 he is Managing Director and in November 2017, he was voted into the position of Chairman & CEO. Since then he has, among other things, represented the BVMI at international level, in the Main Board of the global umbrella organisation, IFPI. He is also the shareholder representative and member of the supervisory board of the Gesellschaft zur Verwertung von Leistungsschutzrechten (GVL).

Florian Drücke has testified as an expert in different Committees of the German Bundestag and the European Parliament as well as before the Federal Constitutional Court. He is the author of multiple articles on digital policy and copyright law and related topics for German media. Beyond that, he is the co-editor of the standard reference work "Handbuch der Musikwirtschaft" (Handbook of the Music Industry) and also a member of a number of boards and committees. Since May 2016 he has been a member of the Deutsch-Französischer Kulturrat and was elected co-president in January 2018.
